RESOLUTION OF THE ENERGY COMMISSION CERTIFYING REVISIONS TO THE  
RESIDENTIAL ALTERNATIVE CALCULATION METHOD REFERENCE MANUAL FOR  
THE 2016 BUILDING ENERGY EFFICIENCY STANDARDS

**WHEREAS**, the 2016 Building Energy Efficiency Standards, amending California Code of Regulations, Title 24, Parts 1, and 6, were adopted by the California Energy Commission on June 10, 2015, with an effective date of January 1, 2017, and

**WHEREAS**, the Warren-Alquist Act, in Public Resources Code Section 25402.1, Subdivision (a), requires the Energy Commission to develop a public domain computer program which will enable contractors, builders, architects, engineers, and government officials to estimate the energy consumed by residential and nonresidential buildings; and

**WHEREAS**, the Warren-Alquist Act, in Public Resources Code Section 25402.1, Subdivision (b), requires the Energy Commission to certify calculation methods for complying with the Building Energy Efficiency Standards; and

**WHEREAS**, the 2016 Building Energy Efficiency Standards that were adopted by the Energy Commission and approved by the Building Standards Commission included Alternative Calculation Method (ACM) Approval Manual, Document Number CEC-400-2015-039-CMF, June 2015, which specifies, among other things, the requirement to create, maintain, and update the Residential ACM Reference Manual.

**THEREFORE BE IT RESOLVED**, that on September 14, 2016, as provided for by the Alternative Calculation Method Approval Manual and Public Resources Code Section 25218, Subdivision (e), the Energy Commission certifies the revised Residential Alternative Calculation Method Reference Manual, Document Number CEC-400-2015-

024-CMF-REV2, September 2016, which provides instructions for meeting the requirements for alternative calculation methods; and

**THEREFORE BE IT FURTHER RESOLVED**, that the Energy Commission directs the Executive Director to take, on behalf of the Commission, all actions reasonably necessary to make the above-referenced documents available and in good form, including but not limited to correcting typographical and other non-substantive errors.
