**STANDING ORDER REGARDING NUMBER OF COPIES  
REQUIRED FOR APPLICATIONS FOR CERTIFICATION, SMALL  
POWER PLANT EXEMPTIONS, NOTICES OF INTENTION,  
OR AMENDMENTS; FORMATTING**

**I. PURPOSE OF ORDER**

California Code of Regulations, title 20, section 1706,<sup>1</sup> directs the California Energy Commission's (Commission) Executive Director to specify the format and number of copies to be submitted to the Commission for Applications for Certification, Small Power Plant Exemptions, Notices of Intention, and any amendments filed under the Commission's power plant siting program. This Standing Order (Order) sets forth the number of copies to be provided to the Commission, to ensure Commission staff have sufficient copies to perform its work and to provide materials for public review.

This Order supersedes two previous Standing Orders, dated November 30, 2011<sup>2</sup> and August 29, 2013.<sup>3</sup> Those previous orders are hereby revoked and shall have no force or effect after this Order is filed with the Commission's Dockets Unit.

**II. NUMBER OF COPIES**

In addition to the requirements for filing of documents as set forth in section 1208, for Applications for Certification, Notices of Intention, Small Power Plant Exemptions and amendments, applicants shall provide to the Commission 20 hard copies and 50 CDs or DVDs. For technical appendices such as air modeling files, applicants shall provide two hard copies and five CDs or DVDs. Applicants may contact Commission program staff to confer whether fewer copies would be acceptable on a case by case basis.


