Purpose of Committee Status Conference

The Committee Status Conference will be held for the purpose of discussing upcoming proceedings, the schedule, and Committee deliberations in closed session. In addition, the Committee has issued a tentative ruling on Staff's Motion for Summary Adjudication² and will hear argument and comment on that tentative ruling. The open meeting will be convened for party discussions, and then public comment will be taken, followed by a closed session. The open meeting will reopen at the conclusion of the closed session for the purpose of reporting any action taken in closed session and adjourning the meeting.

As allowed by California Code of Regulations, title 20, section 1207, a Status Conference may be conducted by the Hearing Officer without either Commissioner being present.

Closed Session

At any time during the conference, the Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.
