SUBJECT: BIO-8 Verification Language Change			

COMMENTS: During a September 23, 2016 conference call between Marsh Landing Generating Station (MLGS) and Energy Commission staff it was agreed to change the verification language for Condition of Certification **BIO-8** so that the Annual Report documenting how each annual payment required by **BIO-8** is spent be included with the submittal of the Annual Compliance Report (ACR) instead of 30 days past the date of receipt from the California Wildlife Foundation. This will facilitate easier tracking of this report by eliminating a separate submittal requirement.

BIO-8 NO CHANGE TO LANGUAGE

Verification: No later than 30 days following the start of project operation, the project owner shall provide written verification to the CPM, USFWS, and CDFG that the first annual payment was made to the California Wildlife Foundation or other third party approved by the CPM in coordination with the USFWS performing similar work in accordance with this condition of certification. The project owner shall provide evidence that it has specified that its annual payment can be used only to assist in noxious weed management and other management activities as required under **BIO-8** as directed by the USFWS. Thereafter, within 30 days after each anniversary date of the commencement of project operation, the project owner shall provide written verification to the CPM, USFWS, and CDFG that payment has been made to the California Wildlife Foundation or other third party approved by the CPM in coordination with the USFWS performing similar work in accordance with this condition of certification. This verification shall be provided annually for the operating life of the project. The project owner also shall request an annual report from California Wildlife Foundation or other third-party approved by the CPM in coordination with the USFWS performing similar work documenting how each annual payment required hereunder was used and applied to assist in noxious weed management and other management activities as required under **BIO-8** at the Antioch Dunes National Wildlife Refuge. The project owner shall provide copies of such reports to the CPM within thirty (30) days after receipt in the Annual Compliance Report.
