1. I am the Deputy Director of the Renewable Energy Division at the California Energy Commission (CEC). I have worked at the CEC since June 2015.

As a Deputy Director at the CEC in the Renewable Energy Division my responsibilities include planning, organizing and directing the programs in the Renewable Energy Division, including overseeing administration of the CEC's Renewables Portfolio Standard (RPS) responsibilities. I am also responsible for advising the CEC, Governor's Office, members of the Legislature and other governmental agencies on matters related to renewable energy and the RPS, and participating in the development, evaluation, and implementation of CEC and state energy policy.
3. I am authorized to make this supplemental declaration on behalf of the CEC and the following matters are true and accurate to the best of my knowledge and belief.
