PALMDALE ENERGY, LLC's STATUS REPORT 11

In accordance with the Committee Scheduling Order dated December 2, 2015, Palmdale Energy, LLC has prepared this Status Report 11 to inform the Committee and to provide recommendations concerning the processing of the Petition For Amendment for the Palmdale Energy Project (PEP). The following summarizes the status of the Commission process since the last status report which was filed on September 15, 2016.

Schedule

On December 7, 2016, Palmdale Energy LLC requested that the dates to file Opening Testimony, Rebuttal Testimony, PreHearing Conference Statements and the PreHearing Conference be delayed to a time to be determined later. The reason for the request for delay is that during the preparation of our testimony we discovered an error in some of the data that was supplied concerning the Air Cooled Condenser. As Staff may recall, we provided data from a vendor earlier this year, to support the ACC thermal plume modeling. Palmdale Energy, LLC is working with multiple vendors to refine data that was used in the ACC thermal plume modeling effort conducted by Palmdale Energy, LLC and Staff. In order to make sure that the record is accurate, we will need some time to validate vendor data and may need to resubmit a new ACC thermal plume modeling report. Therefore, Palmdale Energy, LLC believes that before the Committee hears the case and testimony is filed, the parties may need a Staff workshop to discuss the data and certainly believe Staff will need some time to review any new submittals. Therefore, we requested that the current schedule for the filing of Opening Testimony, Rebuttal Testimony and PreHearing Conference Statements be rescheduled at a time after our efforts are concluded. further requested that a PreHearing Conference not be scheduled at this time. propose to continue filing Status Reports on the 15th of the month to inform the Committee

of progress and to inform the Committee when the parties are ready to file testimony and resume the normal prehearing activities.
