**COMMITTEE RULING RE: INTERVENOR’S MOTION FOR

**BACKGROUND**

On October 18, 2016, Intervenor, Los Cerritos Wetlands Land Trust (LCWLT), filed a Motion for Minor Extension on Deadline to Submit Opening Testimony seeking to extend the deadline to file Opening Testimony from October 19, 2016 to October 21, 2016. (TN 214092).

Also, on October 18, 2016, Energy Commission Staff sent an email to the Parties and Hearing Officer stating, “Staff does not object to the Wetland’s request for an extension of time to file opening testimony.” (TN 214093). On the same day, the Applicant’s attorney, sent an email to the Parties and Hearing Officer stating, “The Applicant will not object, so long as the remaining dates in the schedule do not slip.” (TN 214094).
