## Notice of **Postponement** of Workshop on Proposed Changes to the Guidebook for the New Solar Homes Partnership (NSHP)

The California Energy Commission's (Energy Commission) Renewable Energy Division posted a notice on October 18, 2016 for a workshop to receive comments on the proposed changes to the *Draft New Solar Homes Partnership (NSHP) Guidebook, Tenth Edition*. The workshop scheduled for November 2, 2016 is being postponed until further notice in order to consider recent stakeholder feedback.

### Background

On October 18, 2016, the Energy Commission published a workshop notice about proposed changes to the *New Solar Homes Partnership Guidebook*.

The Energy Commission's Renewable Energy Division is currently drafting an updated edition of the *New Solar Homes Partnership Guidebook*. Staff conducted a public workshop on July 8, 2016 to discuss potential changes with interested parties and have received public comments from stakeholders since that time. Several important changes and streamlining efforts are anticipated to be included in this *Tenth Edition of the NSHP Guidebook*, compared with the *July 2015, Ninth Edition of the NSHP Guidebook*.

A new workshop notice will be posted after a date has been set. The prior notice indicated that staff anticipated the *New Solar Homes Partnership Guidebook, Tenth Edition*, would be considered by the Energy Commission at the December 14, 2016 Business Meeting and, if approved, become effective January 1, 2017. To provide sufficient time for public review and comment, there will be an updated date for consideration by the Energy Commission and an updated adoption date.

## **Availability of Documents**

Staff anticipated posting the *Draft New Solar Homes Partnership Guidebook, Tenth Edition* before the original workshop date of November 2, 2016. The release of this document will be delayed to allow staff to address recent public comment. Public notice will be provided concurrent with or prior to the document being made available.
