# NOTICE OF COMMITTEE STATUS CONFERENCE AND ORDER EXTENDING THE DEADLINE FOR RULING ON LADWP EVIDENTIARY MOTION

**PLEASE TAKE NOTICE** that the Energy Commission Committee.<sup>1</sup> (Committee) assigned to conduct proceedings on the Los Angeles Department of Water & Power (LADWP) Appeal regarding its Renewables Portfolio Standard (RPS) certifications or eligibility has scheduled a Committee Status Conference to review and discuss progress made in the proceeding, consider any then-pending motions or petitions and deliberate in closed session on:

### TUESDAY, NOVEMBER 22, 2016 BEGINNING AT 9:30 a.m. California Energy Commission Charles Imbrecht Hearing Room (Hearing Room B) 1516 Ninth Street Sacramento, CA 95814

There will not be a Committee Conference on November 14, a date the parties were previously requested to hold open on their calendars.

Parties and the public may attend the Committee Status Conference in person at the above location, or by telephone, computer, or mobile device using our "WebEx" conferencing system. As the primary purpose of the Committee Status Conference will be Committee deliberation in closed session, parties and the public are advised not to travel to Sacramento. The public portion of the agenda will be brief. Use the WebEx system instead. For details on how to attend using WebEx, please see the instruction sheet attached to this Notice.

### Background

On January 21, 2016, LADWP filed a Letter of Appeal.<sup>2</sup> appealing the Executive Director's decision denying LADWP's Petition for Reconsideration of Energy Commission staff's denial of LADWP's Application for RPS certification for its Scattergood, Harbor, Valley, and Haynes Generating Stations Using Biomethane from 2009 Shell and Atmos Contracts. The Energy Commission appointed the Committee to conduct hearings and other proceedings on the appeal and recommend a decision for consideration by the full Energy Commission. On July 8, 2016, LADWP filed an additional request that the Committee consider the RPS-eligibility of specified British Columbia hydroelectric generation procurements (BC Hydro request).<sup>3</sup>

### Purpose of the Committee Status Conference

The Committee will conduct the Committee Status Conference for the primary purpose of deliberating in closed session on the issues presented by the appeal and BC Hydro request. It may also address any then-pending motions or other requests that are ripe for consideration. The conference will be convened, public comment taken, and then the closed session will begin. The committee will return at the conclusion of the closed session to announce any reportable actions and adjourn the conference.

As allowed by California Code of Regulations, title 20, section 1205, the Status Conference may be conducted by the Hearing Officer without either Commissioner being present.

# Order Extending the Deadline for Ruling on LADWP's Motion to Exclude

On October 31, 2016, LADWP filed a Motion to Exclude Documents and Supplemental Declarations Submitted by CEC Staff (Motion).<sup>4</sup> Title 20, California Code of Regulations, Section 1211.5(a) requires that the other parties, including Commission staff, respond to the Motion within 14 days of its filing, (November 14). The Presiding Member is required to rule on the Motion within 21 days (November 21) and if he does not rule within 30 days (November 30), the Motion is deemed denied. The Presiding Member is permitted to extend these deadlines.

On November 3, 2016, Hearing Officer Kramer filed a memo<sup>5</sup> asking the parties to state their preferences regarding conducting a hearing on the Motion on November 22, a date for which LADWP has previously said it had schedule conflicts, or a later date. On November 4, LADWP filed a statement that it preferred to have the hearing in

December.<sup>6</sup> Staff said it would be ready to argue the Motion on November 22 but did not object to doing so in December.

We therefore **Order** that the time for the Committee or Presiding Member to rule upon the Motion is extended until December 23, 2016, subject to further extension if necessary. A Hearing on the Motion will be conducted during a Committee Status Conference in December, 2016. Of the two December dates the Committee previously asked the parties to hold—the morning of December 7 and all day on December 15— December 15 appears to better fit the availability of the parties as reported in their November 4 filings. We will confirm the date during or following the November 22 Committee Status Conference.

# **Closed Sessions**

At any time during the conference, the Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.
