Using Your Computer or Mobile Device:

1. Go to <https://energy.webex.com> and enter the above meeting number.
2. When prompted, enter your name and e-mail address.
3. After a moment, an Audio Conference Box will offer you a choice of audio connections:
 - a) To have WebEx call you back: Type your area code and phone number (if you are on an extension, use option b), below) into the drop down box and click "Call Me" (Click on "Use Phone" if you do not see the drop down box.)
 - b) To call into the event from your phone (if, for example, your phone is on an extension or you are an international caller): Use the drop-down box to select "I will Call in" and follow the on-screen directions. Click "All global call-in numbers" if you need to look up an international call-in number.
 - c) To listen and talk over your computer or mobile device: If you have the needed equipment and your computer is configured, click the "Call Using Computer" button. (You may need to click "Use Computer for Audio" to make the button visible.)
4. On a mobile device you may need to install and use the WebEx app instead of the above steps.

2. When prompted enter the meeting number above.
