RESPONSE OF CALIFORNIA ENERGY COMMISSION STAFF TO COMMITTEE REQUEST FOR COMMENTS REGARDING AVAILABILITY FOR A JANUARY COMMITTEE STATUS CONFERENCE AND NOTICE OF MINOR ERRORS IN STAFF'S RESPONSE TO LADWP'S MOTION TO EXCLUDE DOCUMENTS AND SUPPLEMENTAL DECLARATIONS SUBMITTED BY STAFF

California Energy Commission Staff (Staff) hereby responds to the Committee's request for comments regarding the availability of parties for a Committee Status Conference on either January 25 or January 26, 2017. The Committee requested the parties to provide comments regarding their availability on these dates during the Committee Status Conference of December 21, 2016.

Staff is available on January 25, 2017, after the scheduled Energy Commission Business Meeting on this date. Staff is also available for most of the day on January 26, 2017, with the exception of a two-hour window from noon to 2:00, which poses a conflict for one key member of Staff.

Additionally, Staff hereby notifies the Committee of three minor errors in Staff's response (Response) to the Los Angeles Department of Water and Power's (LADWP) *Motion to Exclude Documents and Supplemental Declarations Submitted by CEC Staff* (Motion).¹ in the subject proceeding. Staff's Response was filed on November 14, 2016.² A hearing to consider the Motion as well as Staff's Response was held on December 15, 2016.

During the hearing of December 15 Staff attempted to correct the three minor errors in its Response on the record, but was dissuaded from doing so in the interest of time.³ The three errors in Staff's Response are as follows:

- On page 6, last paragraph, the date of the Committee Status Conference should be September 6, instead of September 9, 2016 as identified in Staff's Response.
- On page 11, last paragraph carrying over to page 12, the name of the LADWP representative that submitted LADWP's applications for RPS certification to the Energy Commission was Oscar Alvarez, not Oscar Herrera as identified in Staff's Response.
- On page 19, first paragraph under Section V, LADWP objection no. 46 pertains to Staff fact no. 12 in Staff's Statement of Disputed Facts, not fact no. 46 as identified in Staff's Response.

These errors were discovered by Staff when preparing for the December 15 hearing. Staff informed LADWP of these errors in writing on December 15 in advance of the hearing and also informed LADWP that Staff intended to correct these errors on the record during the hearing.
