Background

In September 2015, the Energy Commission opened this proceeding (15-OII-01) for the purpose of exploring possible revisions to sections of Title 20 covering post certification activities, including section 1769 Amendments. On October 23, 2015, Staff conducted a Scoping Workshop for Potential Changes to the Commission's Siting and Compliance Process and Procedure.

As a result of the discussions and comments received in connection with that workshop, Staff developed an Action Plan for Updating Compliance Regulations. The Action Plan identified stakeholder support for a number of objectives, including:

- Allowing Staff-approved project changes as long as there are clear parameters for determining what types of modifications can be approved by Staff, and what needs to be approved by the Energy Commission.
- Clarifying what constitutes valid grounds for objection to a Staff recommendation on a request for modification.
- Ensuring timely processing of petitions for modification.
- In cases where project changes may be approved by Staff without approval by the Energy Commission, ensuring that the project with the proposed changes would still comply with all applicable laws, ordinances, regulations and standards and not have a significant impact on the environment.

• Establishing standard rules of procedure related to cost recovery billing under Public Resources Code section 25806(e).

Draft Language

In furtherance of the objectives identified above, Staff has prepared proposed amendments to the Energy Commission's regulations pertaining to the processing of post certification amendments to Energy Commission Decisions set forth in sections 1708 and 1769 et seq. of Title 20 of the California Code of Regulations. Staff's proposed revisions are explained briefly below:

- Staff proposes to revise section 1708 to eliminate provisions which are duplicative of section 25806 of the Public Resources Code, and currently inconsistent with the fees set forth in the statute. In addition, Staff proposes to add subdivision (h) to section 1708, to clarify those activities that constitute "processing the petition to amend" pursuant to section 25806(e) of the Public Resources Code, and are therefore subject to the fee specified in that statute. In particular, all activities of Staff, Staff subcontractors, and Staff counsel in the assessment of a proposed modification, preparation for and participation in hearings, monitoring and implementation of design changes, and all associated expenses are included. Additionally, the costs associated with overseeing compliance through the completion of construction, including the designation of a Delegate Chief Building Official, are included in the costs of processing a petition to amend. However, the activities of hearing officers, commissioners, commissioner advisors, and attorneys advising commissioners is not considered part of the processing of a petition to amend, nor are costs associated with ongoing compliance after the completion of any construction-related to the amendment.
- Staff proposes to revise section 1769, to give Staff the flexibility to approve certain changes to Air Quality conditions of certification, as long as there are no impacts and no violations of applicable laws, ordinances, regulations and standards resulting from the change. Staff also proposes minor and non-substantive revisions to clarify and simplify the language of section 1769.
- Staff proposes to add section 1769.1, which would provide a mechanism for project owners to obtain advice from Staff as to whether or not anticipated activities or changes to a project require the filing of a petition to amend.
- Staff proposes to add section 1769.2, which would allow Staff, under limited circumstances and with the concurrence of the project owner, to initiate proceedings to address ambiguities in decisions and correct or update obsolete

conditions of certification decisions, without imposition of the fee specified in section 25806(e) of the Public Resources Code.
