Background

The Evidentiary Hearings for the Alamos Energy Center have been completed, all evidence has been received, and the evidentiary record is closed. The Committee is now preparing the Presiding Member's Proposed Decision (PMPD). The Committee will hold a closed session to deliberate on matters related to the PMPD.

Purpose of the Committee Conference

The Committee will conduct the committee conference for the primary purpose of deliberating in closed session on matters related to the PMPD. The committee conference will be convened, public comment taken, and then the closed session will begin. The committee conference will reopen at the conclusion of the closed session to make any announcement of a required reportable action and to adjourn the committee conference. No evidence or argument will be taken at the committee conference.

Closed Session Deliberations

During any committee conference, the Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.
