**APPEAL BY LADWP RE RPS CERTIFICATION
OR ELIGIBILITY**

**ORDER GRANTING ENERGY COMMISSION STAFF ACCESS TO
SPECIFIED CONFIDENTIAL DOCUMENTS**

On January 12, 2017, Energy Commission Staff (Staff) and LADWP, the only parties in this proceeding, filed a Joint Stipulation and Request for Committee Order Granting Staff Access to Confidential Information in 16-RPS-02 (Motion).¹ The Motion requests a Committee order allowing Staff access to specified confidential documents filed in this proceeding for “the limited purpose of permitting Staff to commence and complete the verification process to confirm the amount of electricity generated at LADWP’s Valley, Haynes, and Scattergood Generating Stations using biomethane procured under the 2009 Shell and Atmos Agreements.” The biomethane-generated electricity would count toward LADWP’s Renewable Portfolio Standard procurement requirements.

We find good cause to grant the Motion and therefore **Order** that Staff may review the following confidential documents filed in the Docket of this proceeding:

1. LADWP Valley Generating Station 2011-2013 Fuel and Generation Data, TN 213666;
2. LADWP Haynes Generating Station 2011-2013 Fuel and Generation Data, TN 213662;
3. LADWP Scattergood Generating Station 2011-2013 Fuel and Generation Data, TN 213663; and
4. LADWP Heat Rate Ranges, TN 213665.

Access shall be limited to Staff conducting the verification process described above. The confidential information shall not be publicly disclosed and shall otherwise remain confidential pursuant to the Energy Commission’s rules and regulations regarding
