Notice of Staff Pre-Rulemaking Workshop on Updates to the Power Source Disclosure Regulations

California Energy Commission staff will conduct a pre-rulemaking workshop to solicit stakeholder comment on proposed changes to the Power Source Disclosure (PSD) program regulations required by Assembly Bill 1110 (Ting, Chapter 656, Statutes of 2016) on:

- Greenhouse Gas (GHG) emissions intensity factor methodology
- Renewable Energy Credits (REC) retirements in lieu of eligible renewable energy purchases
- Treatment of unbundled RECs in power mix and GHG emissions intensity factors
- Anticipated revisions to the Power Content Label (PCL)
- Other possible programmatic revisions to the PSD regulations

Background

The California Energy Commission (Energy Commission) plans to institute a formal rulemaking to consider modifications to the Electricity Generation Source Disclosure regulations, Title 20, California Code of Regulations, section 1390 et seq. These regulations implement a program informally referred to as the PSD program and the regulations are referred to here as the PSD Regulations. The PSD program discloses to consumers a retail supplier's various sources of electricity compared with the electricity mix of California as a whole.

The PSD program was initially authorized by Senate Bill 1305 (Sher, Chapter 796, Statutes of 1997) which required retail electricity providers to disclose quarterly and annual fuel mix information to retail customers in the form of PCL. Subsequent legislation, including Assembly Bill 162 (Ruskin, Chapter 313, Statutes of 2009) and AB 2227 (Bradford, Chapter 606, Statutes of 2012), authorized amendments to the PSD program. In response, the PSD Regulations were amended through a formal rulemaking in 2016 to address statutory amendments and to make improvements in response to feedback from the regulated entities and retail consumers.

Under AB 1110, the PSD program will additionally require disclosure of a retail supplier's GHG emissions intensity factors for its retail electricity offerings, as well as disclosure of unbundled RECs. The provisions of AB 1110 require that the Energy Commission develop a methodology for the calculation of GHG emissions intensity for each purchase of electricity by a retail supplier to serve its retail customers as well as the GHG emissions intensity associated with statewide retail electricity sales based on the GHG emissions for total California system electricity. Retail suppliers will begin disclosing their emissions on the PCL in 2021 for 2020 calendar year data.

AB 1110 requires the Energy Commission to adopt program guidelines reflecting the updated requirements, by January 1, 2018. These pre-rulemaking activities are the first step in adopting the program guidelines. In addition to implementing AB 1110, during the planned rulemaking process, staff will consider minor revisions to the PSD program regulations to clarify existing provisions, improve program operations, and streamline reporting requirements.

Development of the amendments to the PSD Regulations is currently in the "pre-rulemaking" phase. As needed, pre-rulemaking workshops are held by the Energy Commission to seek early public input for developing and refining draft regulations. The "rulemaking phase" commences with the publication of a Notice of Proposed Regulatory Action and proposed regulations. Once adopted by the Energy Commission, the regulations will be submitted to the Office of Administrative Law for review.
