Hello Sean,

Thank you for scheduling a time to discuss the current impact on the standing of the Title-20 regulations with us today. As we mentioned, all our current major retail customers who sell pools equipped with PMSM motors are in the process of determining how to manage the flow of inventory to California. Therefore, it is imperative for us to be able to advise them on the timeline of the regulation roll-out and the effect it will have on their California business no later than 1 week from now (February 24<sup>th</sup>). As we mentioned, our California business represents roughly \$40 million at retail cost for the pool sets that include PMSM motors. This \$40 million does not account for the accessories and additional items that may be purchased along with a pool set.

Furthermore for your reference, I have attached a listing of our current PMSM pool pumps that are effected by the regulation so that your team can have clarity on the energy consumption that these models produce. When comparing sand filter models (Which are legal in California) versus the filter pump models (Currently illegal), you can see for the pumps that have the same flow rate, the PMSM models consume a significantly lesser amount of energy. In general, pumps with flow rates between  $530 \, \text{gal/hr} - 1500 \, \text{gal/hr}$  make up a vast majority of the market share.

Aside from this information, please let me know if there is any additional information that you would like us to provide that will improve your understanding of our current situation.
