RESOLUTION OF THE ENERGY COMMISSION ADOPTING CORRECTIONS  
TO THE CALIFORNIA ENERGY DEMAND UPDATED FORECAST, 2017-2027

**WHEREAS**, on January 25, 2017, the California Energy Commission adopted the California Energy Demand Updated Forecast, 2017-2027 (CEDU 2016), which describes updated 10-year forecasts for electricity in California and for major utility planning areas within the state and updates the forecasts provided in the California Energy Demand 2016 – 2026, Revised Electricity Forecast by incorporating more recent economic and demographic projections and adjusting for the latest historical data available for consumption, peak demand, temperatures, and electricity rates; and

**WHEREAS**, in late February, Energy Commission staff discovered that the factors applied to the base peak demand forecast to create the 1.5 Form projected extreme weather peaks for San Diego Gas & Electric Company contained in CEDU 2016 were incorrect and on February 27, 2017 docketed the corrections in Docket 16-IEPR-05 and posted the corrections on the Energy Commission's webpage;

**THEREFORE BE IT RESOLVED**, the California Energy Commission hereby adopts the corrected 1.5 Form extreme weather peaks for San Diego Gas & Electric along with any changes identified at its March 8, 2017 Business Meeting, directs Commission staff to make the document available to the public and the Legislature, incorporating changes adopted today as well as any non-substantive changes such as typographical corrections.
