## Purpose of the Committee Conference

The committee conference will reopen at the conclusion of the closed session to make any announcement of a required reportable action and to adjourn the committee conference. No evidence or argument will be taken at the committee conference.

## Closed Session Deliberations

During any committee conference, the Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.
