**THE LOS ANGELES DEPARTMENT OF WATER AND POWER'S REQUEST FOR**  
**THE COMMITTEE TO DEFER THE ENERGY COMMISSION'S CONSIDERATION**  
**OF THE COMMITTEE'S PROPOSED DECISION UNTIL AFTER APRIL 12, 2017**  
**BUSINESS MEETING**

On February 23, 2017, the Committee issued a Memorandum stating that the full Energy Commission review of the Committee Proposed Decision would not occur during the March 8, 2017 Business Meeting, and informing the parties that the Committee's Proposed Decision "is expected to be presented for consideration at the April 12, 2017 Business Meeting."<sup>1</sup> On March 13, 2017, the President of LADWP's Board of Water and Power Commissioners, Mel Levine, requested the opportunity to schedule a meeting with Chair Weisenmiller and Commissioner Hochschild to discuss the potential resolution of this proceeding.<sup>2</sup> On March 13, 2017, LADWP provided CEC Staff written notice of this requested meeting and informed Staff that they were

invited to participate in any meeting scheduled.<sup>3</sup> As of the date of this filing, a date for this requested meeting has not been scheduled. However, this administrative proceeding raises significant policy issues that are of paramount importance to LADWP and its ratepayers. Therefore, LADWP respectfully requests that the Committee defer the full Energy Commission's consideration of the Committee's Proposed Decision until after the April 12, 2017 Business Meeting to provide sufficient time for such noticed meetings to occur.
