- 3 this is the continued closed session for the Huntington Beach
- 4 Energy Project Amendments. This closed session was continued
- 5 from the prehearing conference that we had -- the prehearing
- 6 conference/evidentiary hearing we had on December 21st, last
- 7 year.
- 8 In continuing this closed session, we advised folks
- 9 not to travel to Sacramento today, as the public portion of
