Pursuant to Title 20, section 2505(a)(4), of the California Code of Regulations, Mission Rock Energy Center, LLC (the "Applicant") hereby submits this Repeated Application for Confidential Designation for the cultural resources information contained in the *Mission Rock Energy Center Supplemental Response to Data Request 115 (DPR 523 Historic Built Environment Property Record Forms)* filing submitted in support of the Application for Certification for the Mission Rock Energy Center in the above referenced proceeding.

By letter dated January 11, 2016, the Executive Director approved the initial request for confidential designation of certain documents relating to cultural and paleontological resources within the Mission Rock Energy Center area, including confidential literature and archival research submitted by the Applicant.

The *Mission Rock Energy Center Supplemental Response to Data Request 115 (DPR 523 Historic Built Environment Property Record Forms)* contains cultural resources information that is substantially similar to the previously submitted information and all facts and circumstances relevant to the confidentiality of the information remain unchanged. The Applicant has reasonably determined that the site location of certain cultural resources can be disclosed and not restricted, consistent with applicable law and regulation. Commission Staff may hold a different view. Nevertheless, the Applicant is submitting the information under this Repeated Application out of an abundance of caution and is available to discuss further with Commission Staff.
