Scott,

The rail right of way is called the Santa Paula Branch Line and is owned in fee by the Ventura County Transportation Commission (VCTC) from the Coast Main Line to the eastern County Line. On the portion of right of way that you are interested there are two rail operators permitted to use the track, Union Pacific and the Fillmore and Western. Union Pacific has one train per month making deliveries to Santa Paula and Fillmore and Western only has occasional use of the track west of Santa Paula, so infrequent that there is no schedule. There are several pipelines in that segment of the right of way but I believe that we could accommodate your pipeline.

We would need some type of long term agreement that allowed the pipeline in VCTC's right of way, a lease or license is the typical format for us.

Steve,

It is been a while since we were last in contact. As you may recall the Energy Commission is considering an application from Mission Rock Energy Center, LLC to construct, own, and operate the 225 megawatt Mission Rock Energy Center (MREC) located at 1025 Mission Rock Road (link to more info <http://www.energy.ca.gov/sitingcases/missionrock/index.html>). This proceeding has been delayed for a multitude of reasons but for now commission staff is on track to publish an assessment of potential environmental impacts of this project in Ventura County. Were the project to be approved and constructed, the applicant would construct a natural gas pipeline along the right away of your rail line (map attached). I am not sure of the official name of this rail line. The line runs from Saticoy through Santa Paula and Fillmore to

Piru. I have found it to be referred to as the Fillmore and Western Railway or Santa Paula Branch Line.

I am contacting you today in hopes of acquiring any recent quantitative data on this rail line's usage, specifically the stretch nearest the proposed MREC project site.
