On May 10, 2017, the Committee conducted a status conference. During the conference, LADWP requested that the Committee defer consideration of the Proposed Decision until after the Energy Commission's June 14, 2017 business meeting because the President of LADWP's Board of Water and Power Commissioners, Mel Levine, wanted to address the Energy Commission regarding the Proposed Decision and was unavailable to attend the business meeting on June 14. The Committee orally granted LADWP's request for a deferral and requested comments from LADWP regarding the availability of LADWP to attend the Energy Commission's business meeting on either August 9, 2017 or September 13, 2017. LADWP is unavailable on both of those dates, but is available to attend the Energy Commission's subsequent business meetings on October 11, 2017, November 8, 2017, or December 13, 2017.
