#### Background

On December 30, 2015, Mission Rock Energy Center, LLC (Applicant) submitted the Application to the Energy Commission seeking permission to construct and operate the Proposed Project: a 275-megawatt simple-cycle, natural-gas-fired power generation facility. The Proposed Project would also include construction of a new 6.6-mile, 230 kilovolt transmission line and a new 2.4-mile, 16-inch diameter natural gas pipeline that would connect to Southern California Gas Company's existing high-pressure natural-gas transmission pipeline (Line 404/406).

In its May 2017 Status Report, the Applicant indicated it had withdrawn its position in the California Independent System Operator's (California ISO) Cluster Study 9 and had filed for inclusion in the California ISO's Cluster Study 10.<sup>3</sup> Energy Commission Staff filed a response stating that the information from the California ISO study is important to the analysis of the project, particularly as it relates to transmission system engineering, and requested a Committee Status Conference to discuss the impacts this change may have on the schedule and publication date of the Preliminary Staff Assessment.<sup>4</sup>
