SCE submits its 2017 IOU Revenue Requirement Forms 8.1a and 8.1b, which were adopted by the California Energy Commission (“Energy Commission”) on December 12, 2012. The forms are concurrently filed with this certification. The confidential form is conspicuously labeled “Confidential.” In 2013 and 2015, the Energy Commission granted SCE’s Application for Confidential Designation for the same types of data for which SCE now requests such treatment, but for different years.

As the Energy Commission’s instructions in this docket state, under California Code of Regulation, Title 20, Sections 2505(a)(1)(G) and 2505(a)(4), SCE is not required to submit a new lengthy justification for treating information the Energy Commission previously deemed confidential, provided SCE certifies under penalty of perjury the new information is substantiality similar to the previously granted confidentiality. Below SCE certifies under penalty of perjury the new data on the forms listed above is substantially similar to the data the Energy Commission previously found confidential in 2013 and 2015. The reasons for the confidentiality are the same as those presented in SCE’s 2013 and 2015 applications for confidential designation. SCE therefore request the Energy Commission also treat the 2017 forms as confidential.
