# Notice of IEPR Commissioner Workshop on Transportation Energy Supply Trends and Assessment Report

The California Energy Commission Lead Commissioner for the 2017 Integrated Energy Policy Report (2017 IEPR) will conduct a workshop to discuss and receive comment on California's liquid transportation fuel infrastructure, including production and distribution trends, and regulatory issues that may affect the adequacy of petroleum and alternative transportation fuel in California. # **Background**

California Public Resources Code Section 25301 requires the Energy Commission to prepare an IEPR every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. The Energy Commission uses these assessments and forecasts to provide an analytic foundation for developing energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety. The purpose of this workshop is to provide the Energy Commission and other stakeholders with the latest information on trends in liquid fuel production, storage, and distribution. Energy Commission staff will be displaying new analysis and data on liquid transportation fuels, using aggregated data collected by its Petroleum Industry Information Reporting Act regulations. New analysis and data was designed to improve public knowledge of the liquid transportation fuels supply chain. Stakeholder comments on this subject are encouraged. This workshop will also discuss current issues facing the industry and seek stakeholder input on barriers to efficiency in the liquid transportation fuel supply market.

# Agenda

On July 6, 2017, staff will present, discuss, and solicit public comments on their assessment of California's liquid transportation fuel industry. This workshop will allow people the opportunity to comment on current issues facing this industry that could shape staff's assessment of the future transportation fuel supply, prices, and demand. Presentations from staff will present and discuss items included in the accompanying staff report for this workshop. Topics include:

- Refinery operations and crude oil utilization
- Refinery production of liquid transportation fuels
- Import and export volumes of liquid transportation fuels for Northern and Southern California
- Liquid biofuel production and feedstock utilization
- Industry regulatory changes and issues
- Transportation fuel price scenarios to be used for Transportation Energy Demand Forecast and the 2017-2027 California Energy Demand Forecast

Liquid transportation fuels industry representatives from various perspectives of the fuel supply chain, as well as representatives from agencies regulating that supply chain will also be providing presentations covering the topics listed above.

The Lead Commissioner will consider all oral comments from the workshop and written comments submitted to the Dockets Office and will incorporate those comments into directives to refine and improve the input assumptions used in the 2017 IEPR.
