Notice of Availability of Draft Staff Papers on SB 350 Energy Efficiency Savings Doubling Targets

Senate Bill 350, the Clean Energy and Pollution Reduction Act of 2015 (De León, Chapter 547, Statutes of 2015) requires the California Energy Commission to establish annual targets that achieve a cumulative, statewide doubling of energy efficiency savings by 2030, to the extent doing so is cost effective, feasible, and will not adversely impact public health and safety. Energy Commission staff has published draft energy efficiency savings targets based on cost effective and feasibility analyses contained in two separate staff papers authored by different divisions of the Energy Commission. Energy Assessments Division staff has published draft savings targets for savings to be achieved from ratepayer-funded activities. Efficiency Division staff has published draft savings targets for savings to be achieved from all other sources. Both staff papers will be made available at http://www.energy.ca.gov/2017_energypolicy/documents/.

Energy Commission staff welcome comments on the methodology and scope of these draft targets, particularly if there are potential sources of savings not captured in either of staff's analyses. These staff papers are part of a series of analyses conducted by Energy Commission staff, all of which will be summarized in a future report that will be considered for adoption as the SB 350 2030 energy efficiency savings doubling targets. The development of these staff papers and the adoption of energy efficiency savings doubling targets are part of the 2017 Integrated Energy Policy Report proceeding.
