History: Pre-Rulemaking (Phase 1)

- March 14, 2012: Issued Order Instituting Rulemaking
- March 25, 2013: Released Invitation to Participate
- May 28-31, 2013: Workshops on ITP
- June 13, 2013: Released Invitation to Submit Proposals
- May 28, 2014: Requested additional information on network equipment, commercial clothes dryers, portable electric spas, and pool pumps and motors



History: Pool Pump Motors & Portable Electric Spas

- January 28, 2016: Published draft staff report proposing standards for pool pump motors and portable electric spas
- February 18, 2016: First workshop
- June 16, 2016: Published revised staff report standards for pool pump motors and portable electric spas
- July 13, 2016: Second workshop
- January 18, 2017: U.S. DOE publishes Direct Final Rule setting standards for pool pumps
- July 12, 2017: Published second revised analysis of standards for pool pump motors and portable electric spas



History: Commercial Clothes Dryers

- February 7, 2017: CA IOUs docket CASE Test Procedure
- July 18, 2017: Published Draft Staff Analysis of Testing, Certification and Marking Requirements for Air Filters and Commercial Clothes Dryers




History: Air Filter Labeling

- May 13, 2015: Adopted testing, reporting, and marking requirements for air filters, effective July 1, 2016
- March 8, 2017: Adopted emergency regulations to delay the compliance date to April 1, 2019.
- June 16, 2017: Opened formal "certification" rulemaking to make the delay permanent.
- July 18, 2017: Published *Draft Staff Analysis of Testing, Certification and Marking Requirements for Air Filters and Commercial Clothes Dryers*
