Purpose of the Committee Conferences

The September 12 Committee Conference will be held to review and discuss prehearing statements and any prehearing motions filed by the parties in anticipation of the September 14 Evidentiary Hearing. Below, the Committee orders the parties to submit all prehearing motions by September 8, 2017. The Committee Conference will be convened, prehearing statements and motions discussed, public comment taken, and then the closed session will begin. The public portion of the Committee Conference will reopen at the conclusion of the closed session for the purpose of reporting any action taken in closed session, after which the conference will be adjourned. Parties may choose to attend the Committee Conference in person or via our WebEx remote attendance system.

The September 18 Committee Conference will be held primarily for Committee deliberation in closed session. The Committee Conference will be convened, public comment taken, and then the closed session will begin. The public portion of the Committee Conference will reopen at the conclusion of the closed session for the purpose of reporting any action taken in closed session, after which the conference will be adjourned.

The public is advised not to travel to Sacramento as the public portion of the Committee Conference agendas will be relatively brief. The public is encouraged to use the WebEx remote attendance system instead.

Purpose of the Evidentiary Hearing

The Evidentiary Hearing is an administrative adjudicatory proceeding to receive evidence into the formal hearing record from the parties. Only the parties (Applicant, Energy Commission Staff, and Intervenors) may present evidence for introduction into the formal hearing record, which is the only evidence upon which the Energy Commission may base its decision under the law. Testimony offered by the parties shall be under oath. Each party has the right to present witnesses, introduce exhibits, and to rebut the evidence of another party.

The subject to be discussed is the *Moorpark Sub-Area Local Capacity Alternative Study* prepared by the California Independent System Operator (California ISO) filed on

August 16, 2017 (California ISO Study). The parties were invited to submit additional evidence in response to the California ISO Study by August 30, 2017. 3

Local, state, federal, and tribal governmental agencies may participate in the Evidentiary Hearing as necessary. (Cal. Code Regs., tit. 20, § 1714.5.) Elected officials and members of the public may present public comments at this event and/or submit written comments via the Energy Commission's e-Commenting system at:

ORDER FOR PREHEARING STATEMENTS INCLUDING WITNESS IDENTIFICATION AND EXHIBIT LISTS

All parties are **ORDERED** to file a Prehearing Statement and Exhibit List <u>no later than</u> 5:00 p.m. on Thursday, September 7, 2017.

The Prehearing Statements must specify under separate headings:

- The issues in dispute that require adjudication and the precise nature of the dispute for each issue. Issues are limited to those related to the California ISO Study;
- 2. The identity of each witness the party intends to sponsor at the Evidentiary Hearing, the subject area(s) about which the witness(es) will offer testimony, whether the testimony will be oral or in writing, a brief summary of the testimony to be offered by the witness(es), qualifications of each witness, the time required to present testimony by each witness, and whether the witness seeks to testify telephonically;
- 3. Subject areas upon which the party desires to question the other parties' and the California ISO's witness(es), a summary of the scope of the questions (including questions regarding witness qualifications), the issue(s) to which the questions pertain, and the time desired to question each witness. (Note: A party who fails to specify the scope, relevance and time for questioning other parties' witness(es) risks preclusion from questioning witnesses on that subject area.); and
- 4. A list identifying exhibits with transaction numbers (i.e., TN 215157) that the party intends to offer into evidence during the Evidentiary Hearing. Do not list exhibits previously identified in connection with the February 7-10, 2017 or July 26-27, 2017 Evidentiary Hearings. The Exhibit List shall be formatted as four columns. The first column shall list the proposed Exhibit Number. The second column shall contain the Transaction Number of the corresponding document. The third column shall contain the Title of the Document as shown in the docket log. The fourth column shall state the Subject Area(s) to which the exhibit applies. Hearing Unit Staff from the Energy Commission will then add the exhibit number

information into the e-filing system. Parties and the public may generate an upto-the-moment Exhibit List by clicking the link on the proceeding's web page.⁴

All documentary evidence must be filed in this proceeding's docket (15-AFC-01) and have a transaction number assigned by the Energy Commission's electronic filing system in accordance with the Revised General Orders Regarding Electronic Document Formats, Electronic Filing and Service of Documents and Other Matters, filed August 5, 2016. Exhibits without a transaction number, or not filed in this proceeding's docket, will not be received into evidence absent a showing of good cause.

Failure of a party to comply with the filing requirements stated in this Order may preclude that party from introducing evidence and otherwise participating in the Evidentiary Hearing.

ORDER FOR PREHEARING FILING OF EVIDENTIARY OBJECTIONS AND MOTIONS

All parties are **ORDERED** to file any objections or other motions regarding the proposed evidence, testimony, and exhibits of another party <u>no later than 5:00 p.m. on Friday, September 8, 2017</u>. Such objections and motions will be considered during the September 12, 2017 Committee Conference. Absent a showing of good cause for filing or making an objection or motion after the above deadline, objections and motions will not be considered following the September 12 Committee Conference or during the September 14 Evidentiary Hearing.

Formal and Informal Hearing Procedures

Pursuant to California Government Code section 11445.10 et seq., and California Code of Regulations, title 20, sections 1207 and 1210, the Committee may conduct all or portions of the Evidentiary Hearing using an informal procedure. The Committee will use the informal procedure at this Evidentiary Hearing, but may switch to the formal procedure if it becomes necessary. All parties and their representatives shall be prepared to use either procedure.

The <u>informal hearing procedure</u> the Committee will use for this Evidentiary Hearing would generally proceed in the following order:

- 1. All parties' witnesses on the subject area at hand are sworn in as a panel;
- 2. Applicant's witnesses provide a brief opening statement summarizing the key points and conclusions of their testimony;
- 3. Energy Commission Staff's witnesses provide a brief opening statement summarizing the key points and conclusions of their testimony;
- 4. Intervenors' witnesses provide a brief opening statement summarizing the key points and conclusions of their testimony;

- 5. Open discussion among the witness panelists led by the Committee;
- 6. Parties may follow up with questions to their own (or other) witnesses to the extent the Committee finds the questioning productive;
- 7. At the conclusion of the parties' examination of the witnesses, the Committee may ask witnesses additional questions or allow panelists to ask additional questions of each other and to offer follow-up answers; and
- 8. Each party will be given up to 10 minutes at the close of testimony to present any relevant points or closing arguments it was unable to raise above.

The <u>formal hearing procedure</u> would generally proceed as follows:

- 1. A party asks direct questions of its witnesses on the subject area at hand, either one at a time or seated as a panel;
- 2. The other parties then, in turn, ask cross-examination questions of the witness or panel who just testified;
- 3. The offering party can ask re-direct questions at the Committee's discretion;
- 4. The other parties can ask re-cross questions at the Committee's discretion; and
- 5. Repeat the above steps for the witnesses offered by the other parties.

Notice of Closed Session Deliberations

At any time during the Evidentiary Hearing or Committee Conferences, the Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.

Transcripts

Parties are responsible for identifying errors in the transcripts of the proceedings. Corrections to the transcripts must be submitted to the Committee within 30 days of the filing of a transcript.

Public Participation

It is not necessary to be an intervenor to participate in the public process.
