Pursuant to Title 20, section 2505(a)(4), of the California Code of Regulations, Russell City Energy Company, LLC (the "Applicant") hereby submits this Repeated Application for Confidential Designation for the Cultural Resources *Data Response A7* (TN #: 220698) submitted in support of the Petition for Modification for the Russell City Energy Center in the above referenced proceeding.

By letter dated August 14, 2014, the Executive Director approved the initial request for confidential designation of certain documents relating to cultural resources within the project area:

The California Public Records Act provides for the nondisclosure of archaeological site information and reports. Gov. Code, § 6254.10. The Public Records Act also recognizes the confidentiality principles of federal law. (Gov. Code, § 6254(k).) The Archaeological Resources Protection Act establishes a clear, national legal policy that all types of archaeological, paleontological, and cultural resource site locations must be kept confidential in order to preserve them. (16 U.S.C. § 470hh.) Non-disclosure of cultural resources, such as the location information that you have submitted in Appendix B, is expressly in the public interest.

Data Response A7 will contain similar information in responding to Staff Data Request A7:

A7. Please provide a site plan or map that clearly indicates the location where the recent April 24, 2017, discovery of a cultural resource was found during excavation for the demineralization

project and submit that under confidential cover. The goal is for staff to be able to discern the proximity to the current proposed project.

The *Data Response A7* contains cultural resources information that is substantially similar to the previously submitted information and all facts and circumstances relevant to the confidentiality of the information remain unchanged. In addition, the Commission Staff specifically requested that the Applicant submit this Data Response "under confidential cover."
