On behalf of greenNet Registry LLC, I am pleased submit this Application for Confidential Designation and supplemental documentation in response to Title 20, S. 1674 and Joint Appendix 7, for greenNet to become a Certified HERS Provider and Rating System for the 2016 Standards. We request 4 Years of Confidentiality (equaling 1 code cycle of 3 years +1 extra year) to prevent statewide HERS applicants or Raters from discovering, using, attaining knowledge of, copying or duplicating any elements of, or revealing trade secrets of our electronic rating system, computer engineering, software programming, secured network, coding, business strategy, training, testing, quality assurance materials, or written materials which took significant time, talent and treasure to develop, design, program and produce for the greenNet rating system and HERS providership. This information has not been previously disclosed to the public, and disclosure would allow competitors to discover, view, duplicate, copy, photograph, know, rewrite, rework or game greenNet proprietary information causing irreparable damage to our business. This information has not been previously disclosed to the public. 4 Years (equaling 1 code cycle of 3 years +1 extra year is sufficient time for greenNet confidential information to be disclosed as the exhibit contents will be outdated and disclosure of the information will pose less of a competitive disadvantage at that time.


