Dear Chair Weisenmiller:

Thank you for allowing the Department of Water and Power additional time hearing in the above matter, scheduled for a hearing before the Energy Commission on **October 11, 2017 at 10:00 a.m.** Given the additional time allotted, we write to inform the Energy Commission that Todd J. Guerrero, an attorney in good standing in Minnesota but not licensed in California, intends to appear on behalf of DWP at the hearing along with other DWP representatives.

Energy Commission's rules of practice and procedure state "[a]ny person may designate any other person, to represent him or her for any purpose." Cal. Code Regs., tit. 20, § 1206. California Energy Commission, CEC-140-2017-002, page 7. We interpret this rule of practice and procedure to mean that Mr. Guerrero need not be a lawyer nor a lawyer licensed in California to appear before the Energy Commission on behalf of DWP.

We recently raised the issue of an out-of-state lawyer appearing before the Energy Commission to your Chief Counsel and while she did conclude one way or the other, she referenced Rule 9.47 of the California Rules of Court. That rule addresses out-of-state lawyers "practicing law" temporarily in California as part of a matter in litigation. Given this matter is before the Energy Commission and not in court, we believe the Energy Commission's rules of practice and procedure take precedence over the State's court rules and thus Rule 9.47 is inapplicable. To the extent the Energy Commission disagrees, however, we enclose an application
