# Notice of IEPR Commissioner Workshop on the California Energy Demand 2018-2030 Revised Forecast

The California Energy Commission will conduct a workshop to explore a range of perspectives on the future of electricity and natural gas demand in California over the next 12 years. Staff from the Energy Commission will present 12-year forecasts of electricity and natural gas consumption and electricity peak demand. Energy Commission staff will also present details regarding the treatment of additional achievable energy efficiency (including efforts to achieve SB 350 energy efficiency targets), self-generation, electricity rates, hourly load forecasts, and climate change impacts on electricity and natural gas demand.

Chair Robert B. Weisenmiller will conduct the meeting. Chair Weisenmiller is the Lead Commissioner for the 2017 Integrated Energy Policy Report (2017 IEPR) and for electricity and natural gas issues. Other Commissioners at the Energy Commission and the California Public Utilities Commission (CPUC) may also attend and participate in the workshop. A quorum of Commissioners from the CPUC and/or the Energy Commission may be in attendance, but no votes will be taken.

### **Background**

On August 3, 2017, the Energy Commission held a public workshop to present its preliminary 10year forecast of electricity consumption, peak demand, and end-use natural gas consumption for each planning area within California. Following the workshop, Energy Commission staff developed a revised set of forecasts that incorporate stakeholder input and direction from the IEPR Lead Commissioner as well as updated historical data for peak demand and consumption.

The preliminary forecast included only those efficiency efforts that have firm funding and have either already been implemented or have established implementation plans. Since some additional efficiency impacts are very likely to occur over the next 12 years, Energy Commission staff worked with the CPUC and the publicly owned utilities to develop a set of efficiency scenarios incremental to the baseline demand forecast. These efficiency scenarios will be presented alongside the baseline forecast at the December 15, 2017, workshop.

Following this workshop, staff will consider stakeholder comments and direction from the IEPR Lead Commissioner in developing a set of final forecasts to be used in a variety of energy policy and planning activities. Final forecasts will be considered for Energy Commission adoption at a business meeting in January 2018.

## **Agenda**

Staff presentations will cover the revised forecast and methods, including a new hourly load forecasting model, distributed generation impacts, electric vehicle scenarios, residential time-of-use pricing, additional achievable energy efficiency, and individual utility forecasts. For all topics to be discussed at this workshop, utilities are invited to provide comments or make presentations.
