This purpose of this letter is serve the Stockton Port District (Port) with an updated complaint of noncompliance with the Renewables Portfolio Standard (RPS) for the 2011- 2013 compliance period and a related motion.

In my letter of December 29, 2017, I informed you of the California Energy Commission staff determination regarding the Port's noncompliance with the RPS, and that as a result of this determination, a complaint of noncompliance and related motion were being filed against the Port. A copy of the complaint against the Port and the related motion were included with my December 29 letter.

The complaint against the Port and related motion were also served upon Robert Weisenmiller and Kourtney Vaccaro, the Chair and Chief Counsel of the Energy Commission, respectively. In a letter dated January 8, 2018, Chair Weisenmiller rejected the complaint against the Port because the complaint was not properly signed, but allowed the complaint to be re-filed, without prejudice, with a proper signature.

In accordance with the Chair's January 8 letter, please find enclosed an updated complaint against the Port for noncompliance with the RPS for the 2011- 2013 compliance period. The updated complaint is dated January 8, 2018, and has been re-signed with my signature to address the issue identified in the Chair's letter. Except for the date and my signature, the updated complaint is identical to the complaint that was served on December 29, 2017.

The enclosed updated complaint and related motion are being served on the Port in accordance with the Energy Commission's regulations in California Code of Regulations, title 20, section 1233.1 (b). The Energy Commission will conduct a hearing

to adjudicate the complaints, unless the Port waives the hearing in accordance with section 1233.1, in which case the Energy Commission need not conduct a hearing.
