Agenda

This hearing will contribute to the rulemaking phase of the development of the 2019 Energy Code and the 2019 CALGreen Code. The hearing will include a presentation of the proposed revisions to Title 24, Parts 1, 6 and 11, as well as the Alternative Calculation Method Manual. Background

The Energy Commission began its rulemaking phase of the development of the 2019 Energy Code and the 2019 CALGreen Code on January 19, 2018, with the publication of the Notice of Proposed Action (NOPA) by the Office of Administrative Law. Prior to this publication, the Energy Commission spent nearly a year in pre-rulemaking development of both code updates. The Energy Commission's Energy Code recommendations are required to be cost effective over the life of the measure, and are implemented on a prescriptive and performance basis. The CALGreen Code's provisions are voluntary and are not required to be cost effective.

Public Comment

Oral comments. The Lead Commissioner for Efficiency will accept oral comments during the hearing. Comments may be limited to three minutes per speaker. Any comments will become part of the public record in this proceeding.

Written comments. Written comments that may be discussed at the hearing should be submitted to the Dockets Unit by 4:00 p.m. on February 1, 2018. Written comments will be also accepted at the hearing, however, the Energy Commission may not have time to review them before the conclusion of the meeting. Note that written comments on the proposed 2019 Energy Code and 2019 CALGreen Code can be submitted to the Docket Unit through March 5, 2018.
