To Whom It May Concern,

I would like to express strong opposition to the CEC's proposal to remove HERS verification of Solar V systems, *especially since the CASE report on Solar PV supported HERS verification of PV as a required energy measure*. As currently written, the CEC assumes that resource strained building departments will take on the complicated and time consuming verification of PV. This work *should* be completed by HERS Raters. HERS Raters have specialized solar training that building department inspectors do not have. Plus, since a HERS Rater is already required on newly constructed homes, the cost to add the HERS inspection is small compared to the benefit of ensuring proper installation of the PV system.
