Committee Conference of March 7, 2018**

Proposed Schedule for Proceeding

- If the Committee approves Staff's motion for a bifurcated, two-phased proceeding, a proposed schedule could be as follows:
  - March 7, 2018: Committee Conference, approval of Staff motion.
  - March 21, 2018: Stockton answer. (14 days after Committee ruling on motion.)
  - April 5, 2018: Staff's response to answer, if any. (15 days after answer.)
  - April 16, 2018: Stockton reply to Staff response, if any. (10 days after response.)
  - TBD: Briefing on any legal issues, if requested by Committee.
  - May 22, 2018: Hearing on mitigating circumstances, unless briefing schedule necessitates a delay, or parties waive hearing (allowing decision to be made based on written submissions).
  - TBD: Committee Proposed Decision on mitigating circumstances.
  - TBD: Opening comments on Proposed Decision. (15 days after decision.)
  - TBD: Reply comments on Proposed Decision. (15 day after opening comments.)
  - TBD: Final Committee Decision.
  - TBD: Commission consideration of Final Committee Decision (if Decision excuses Stockton based on mitigating circumstances).
  - TBD: Schedule Phase 2 of proceeding (if Committee Decision does not excuse Stockton based on mitigating circumstances.)
  
- If the Committee does not approve Staff's motion for a bifurcated, two-phased proceeding, a proposed schedule could be as follows:
  - March 7, 2018: Committee Conference, disapproval of Staff motion.
  - April 6, 2018: Stockton answer. (30 days after Committee ruling.)
  - April 23, 2018: Staff response to answer, if any. (15 days after answer.)
  - May 3, 2018: Stockton reply to Staff response, if any. (10 days after response.)
  - TBD: Briefing on any legal issues, if requested by the Committee.
  - June 8, 2018: Hearing on alleged violations and mitigating circumstances, unless briefing schedule necessitates a delay, or parties waive hearing.
  - TBD: Committee Proposed Decision on alleged violations and mitigating circumstances.
  - TBD: Opening comments on Proposed Decision. (15 days after decision.)
  - TBD: Reply comments on Proposed Decision. (15 day after opening comments.)
