### ATTACHMENT 3(a)

Applicant requests a confidential designation for the information in Attachment A because this information constitutes proprietary trade secret information under Government Code section 6254.15. This information reveals confidential market share, procurement and RPS compliance strategy.



### ATTACHMENT 3(b)

Public disclosure of this information could competitively harm Applicant because the information reflects Applicant's total historical retail load in the service territories of the California investor-owned electric utilities for the year 2017. Public disclosure of this information would reveal Applicant's net short position in the immediate past period, including its RPS net short position, thereby placing Applicant at a competitive disadvantage in the wholesale and retail electricity markets. A confidentiality period of one (1) year prevents the disclosure of Shell Energy's most recent annual procurement and retail sales information. This one (1) year confidentiality period for "historical" information is consistent with the CPUC's confidentiality rules under D.06-06-066.

#### ATTACHMENT 4
