**STAFF REQUEST FOR CLARIFICATION OF  
COMMITTEE ORDER – DENIAL OF STAFF MOTION TO BIFURCATE**

California Energy Commission Staff (Staff) hereby requests clarification of the Committee’s May 29, 2018 order, *Denial of Staff Motion to Bifurcate* (Order). On page 2 of the Order, the Committee directs Staff to do the following:

Staff shall notify the Committee on or before June 15, 2018 if it plans to present additional evidence relevant to the Port’s specific factual claims. If Staff plans to present such additional evidence, it must be filed by declaration on or before May 25, 2018. Such declaration shall be subject to the same requirements applicable to the Port’s declaration.<sup>1</sup>

Staff requests clarification regarding the Committee’s direction that Staff, if it plans to present additional evidence, file such evidence by declaration on or before May 25, 2018. Staff believes the “May 25, 2018” filing date is a typographical error and that the Committee intended to establish a filing date of either June 25, 2018, or some later date.

Staff requests that the Committee clarify the correct filing date.
