I'm writing to ask you to deny NRG's request for a further extension on the application for the Puente Power Plant.

Puente was always a bad idea. The proposal to build more fossil fuel infrastructure on Oxnard's beaches is inconsistent with California's goal of a clean energy future, and its commitment to expanding environmental justice. This project would be damaging to California communities. The city of Oxnard already has some of the highest asthma rates in the state. We should be working to clean the air, not endanger California communities with more pollution.

Additionally, this project is uneconomical and unnecessary. Puente would cost more than twice as much as it would cost to meet the same electricity needs with renewables. Clean energy solutions can create more good, local jobs in the Oxnard area--for a fraction of the cost.

I am thankful that the Commission recognized the environmental consequences of Puente and announced its intention to reject the facility's permit. Now, Southern California Edison is pursuing clean alternatives to Puente.

This is a project whose time has passed. Now more than ever, California's leadership is essential to lead our nation toward a clean energy economy – we aren't going to get there by building uneconomical projects that lock in more pollution and dependence on fossil fuels. It is time for the Commission to take the final step, and officially deny NRG's application.

The residents of Oxnard have spoken out against Puente at every opportunity, and deserve the finality of a final Commission decision. Please deny NRG's request for an extension, issue a final decision, and provide closure to the residents of Oxnard.
