Background

This report helps identify opportunities to improve access to clean energy technologies for low-income customers and disadvantaged communities, increase clean energy investment in those communities, and improve community resilience to grid outages and extreme events. This report tracks progress on implementation of the recommendations included in the Energy Commission's December 2016 *Low-Income Barriers Study* mandated by Senate Bill 350 (de León, Chapter 547, Statutes of 2015) and monitors performance of state-administered clean energy programs in low-income and disadvantaged communities across the state. The staff report and interactive web map are at http://www.energy.ca.gov/2018_energy_policy/documents/.

During a May 16, 2017 IEPR workshop, staff outlined a draft framework and proposed indicators that could be used to track California's progress on energy equity (https://efiling.energy.ca.gov/URLRedirectPage.aspx?TN=TN217611_20170515T154916_California_Clean_Energy_Equity_Framework_and_Indicators.pdf). The Energy Commission requested public comments on the draft framework and feedback was incorporated into a draft tracking progress report, which was posted March 2, 2018. The draft report focused on a subset of indicators proposed in the original framework and highlighted energy equity performance for various regions of the state. The final report and

interactive web map incorporated feedback from the draft report. Staff plans to update this report annually.
