In accordance with the Committee Scheduling Order dated May 1, 2017, Stanton Energy Reliability Center, LLC (SERC, LLC) has prepared this Status Report No. 14 to inform the Committee of the progress made in the review of the Application For Certification (AFC) for the Stanton Energy Reliability Center (SERC). The following summarizes the status of the Commission process since the filing of Status Report No. 13 on May 15, 2018.

Final Staff Assessment

Staff published the Final Staff Assessment (FSA) on June 7, 2018. The SERC, LLC team has reviewed the FSA and is pleased to report that at this time it does not have any disagreements with Staff over its findings, conclusions or proposed conditions of certification.

Schedule

SERC, LLC will file its PreHearing Conference Statement, Proposed Exhibit List and Opening Testimony on or before June 22, 2018. SERC, LLC does not anticipate the need for Rebuttal Testimony or the need for live witnesses at the evidentiary hearing. If the Committee has questions that it would like SERC, LLC to address, it would be helpful to know the subject matters prior to the evidentiary hearing to make sure a witness is physically present. As always, other expert witnesses will be available by telephone if necessary.

SERC, LLC also believes that since the intervenors are not active in the proceeding and since SERC, LLC is in full agreement with the FSA, there will be nothing for the Committee

to adjudicate. Therefore, there should be no reason for briefing. To that end, SERC, LLC requests the Committee to prepare the Presiding Member's Proposed Decision (PMPD) for publication prior to September 8, 2018 to allow the PMPD public comment period and the PMPD Conference Hearing to take place in time to facilitate full Commission consideration of the Final Decision at the October 10, 2018 Commission Business Meeting.
