# Background

Senate Bill 110, (Committee on Budget and Fiscal Review, Chapter 55, Statutes of 2017), appropriates up to \$75 million in funding from the California Clean Energy Jobs Act (Proposition 39, 2012) to be administered by the Energy Commission. This funding will be awarded to eligible public school districts and county offices of education (COE) to retrofit or replace old diesel school buses throughout California. The Energy Commission's School Bus Replacement Program consists of three funding components: (1) school bus replacement in two phases; (2) providing infrastructure to support replacement buses; and (3) providing workforce training and development opportunities and resources to support electric school bus maintenance, charging, and operations.

A solicitation (<u>GFO-17-607</u>) for phase one of the school bus replacement component was released in May 2018 to public school districts and COE. The Energy Commission will establish a list of buses eligible for replacement based on the applications received. The deadline to submit applications is September 20, 2018.

This Solicitation to Establish Bulk Purchase Pricing for Electric School Buses Concept Workshop will focus on phase two of the school bus replacement component. Public comment will be solicited from school bus manufacturers, as well as public school districts and COE on the development of a solicitation for school bus manufacturers to design, construct, and deliver the replacement school buses, based on the applications received in phase one. The results from the workshop will assist Energy Commission staff in developing the criteria and specifications for the solicitation design for school bus manufacturers, which is scheduled to be released in late 2018.

Staff from the Energy Commission Fuels and Transportation Division will discuss a draft concept under consideration for the solicitation.
