**Change Of Date For Hearing And Possible Adoption of the Proposed
Amendments To Title 20 Commission Siting And Procedure Regulations**

As noticed on May 25, 2018, the California Energy Commission set a date of July 11, 2018 for consideration and possible adoption by the Commission of the proposed amendments to Title 20 of the California Code of Regulations relating to the Commission’s siting and procedure regulations. **The Commission will not consider adoption of these matters on July 11, 2018, and the hearing for consideration and possible adoption of the proposed amendments and adoption of a notice of exemption under the California Environmental Quality Act has been postponed to August 1, 2018.**

PUBLIC HEARING (Gov. Code, §11346.5(a)(1))

The Energy Commission will hold a public hearing for consideration and possible adoption of both an exemption under the California Environmental Quality Act, and the proposed regulatory language on the following date and time unless the Commission decides to modify the regulatory language requiring an additional public comment period.
