I am unalterably opposed to ANY and ALL such proposals FOR FEDERAL WATERS OFF CALIFORNIA'S COAST. NO ON SHORE SUPPORT FACILITIES SHOULD BE PERMITTED UNDER ANY CIRCUMSTANCES .

FOR EXAMPLE , THE OBSCENE PROPOSAL FOR MULTIPLE 600 FOOT TURBINES ANCHORED IN 2100 TO 3100 FEET OF WATER 35 MILES NW OF CAMBRIA.
