# Notice of Webinar for Pre-Solicitation Concepts for Zero-Emission Vehicle Infrastructure Manufacturing

California Energy Commission (Energy Commission) staff will conduct a public webinar to discuss a pre-solicitation concept for zero-emission vehicle (ZEV) infrastructure manufacturing. The Energy Commission is seeking input from stakeholders on a proposed solicitation concept for a future solicitation for eligible manufacturers of electric vehicle (EV) chargers and components and hydrogen refueling station (HRS) components and equipment. # **Background**

Assembly Bill 118 (Núñez, Chapter 750, Statutes of 2007), created the Alternative and Renewable Fuel and Vehicle Technology Program (ARFVTP). The statute authorizes the Energy Commission to develop and deploy alternative and renewable fuels and advanced transportation technologies to help attain the state's climate change policies. AB 8 (Perea, Chapter 401, Statutes of 2013) reauthorized the ARFVTP through January 1, 2024.

Since 2009, the ARFVTP has awarded \$49 million for grants to co-fund manufacturing projects mostly for ZEV production. ARFVTP manufacturing investments spur significant direct and indirect job creation, tax revenue, and regional economic development.

In January 2018, Governor Brown issued Executive Order B-48-18, which calls for the Energy Commission to support the development and installation of 250,000 EV charging stations and 200 HRS by 2025 to support market growth to five million ZEVs by 2030.

On May 4, 2018, the Energy Commission hosted a roundtable discussion in Long Beach titled "Bringing Zero-Emission Infrastructure Technology Manufacturing to California." Discussion centered on actions California and local governments could take to expand or recruit California-based manufacturing in all or part of the ZEV infrastructure supply chain while harnessing economic growth and job creation.

On August 6, 2018, the Energy Commission conducted a Fuels and Transportation Technology Merit Review Workshop to highlight lessons learned from previous ARFVTP funding awards. The workshop also explored challenges and opportunities to locate, expand, and recruit manufacturers of vehicles, infrastructure, and supply chain components in California. Discussion included California workforce development relating to existing and future projects.

The "2018-2019 Investment Plan Update for the Alternative and Renewable Fuel and Vehicle Technology Program" describes funding for ZEV infrastructure including investments in manufacturing and workforce development.<sup>1</sup>

This webinar presents a pre-solicitation concept (attached) for a ZEV infrastructure manufacturing solicitation. Comments, discussion, and feedback to the concept will be solicited during and after the webinar. Energy Commission staff will evaluate the input that will be used to inform the development of a solicitation.

This webinar will:

- Review the ARFVTP investment portfolio for manufacturing.
- Describe the solicitation and agreement development process.
- Facilitate stakeholder discussion on the pre-solicitation concept.

Potential solicitation applicants and ZEV infrastructure stakeholders are strongly encouraged to attend and participate.
