A. *Pursuant to Government Code section 11346.4, subdivision (a), California Code of Regulations, title 1, section 86, and Government Code section 11104.5, subdivision (a), at least 45 days before the close of the public comment period on the adoption of the proposed 2019 revisions to the California Building Efficiency Standards, also known as the California Green Code, in the California Code of Regulations, title 24, part 11, Appendix A4 Division A4.2 and Appendix A5 Division A5.2, the Energy Commission provided notice of this proposed action to the following persons in the manner indicated:*

(3) *A representative number of small business enterprises or their representatives that are likely to be affected by the proposed action; and*

This notice was provided via email to the efficiency and building standards list serve which includes many small businesses that have expressed an interest in Energy Commission actions related to these regulations.

The notice was also posted on the Energy Commission's website January 18, 2018.

- (4) *All persons and groups of persons whom this agency believes to be interested in this proposed action.*


This notice was provided via email to the building standards list-serve on January 19, 2018, which consists of all those who have expressed an interest in Energy Commission actions related to these regulations.
