Staff from the California Energy Commission, California Public Utilities Commission (CPUC), California Air Resources Board (CARB), and California Independent System Operator (California ISO) will conduct a two-day workshop on the update to the California Vehicle-Grid Integration (VGI) Roadmap. Background

In 2012, Governor Edmund G. Brown, Jr. issued Executive Order B-16-2012, setting a target of 1.5 million zero-emission vehicles (ZEV) on California roads by 2025. To help achieve this goal, an interagency working group on ZEVs developed the 2012 ZEV Action Plan, which identified activities to advance California's ZEV goals—including the development of the <u>2014 California VGI Roadmap</u>.

The Energy Commission's 2017 Integrated Energy Policy Report (IEPR) recommended updating the VGI Roadmap to reflect "the needs to use open standards, to return the value of grid integration to stakeholders, and to commercialize prior investments in research and maintain leadership in advanced technology development."

Accordingly, the Energy Commission, CPUC, CARB, and California ISO have begun a public process to update the roadmap to discuss actions the state can take to advance VGI, help meet the state's 2025 ZEV adoption goals, and discuss actions to achieve the goals established by Governor's Executive Order B-48-18 to put at least 5 million ZEVs on California roads by 2030 and install 250,000 electric vehicle chargers, including 10,000 direct current fast chargers, by 2025. The update will also address VGI advancements for medium- and heavy-duty vehicles, expansion of the low-income and disadvantaged communities market, and new state policies, such as the <u>Senate Bill 100</u> (de León, Chapter 312, Statutes of 2018) mandate of 100 percent renewable and zero-carbon electricity sales by 2045.

On September 6, 2018, Energy Commission staff held a webinar to kick-off the roadmap update and presented a proposed approach, schedule, and proposed activities and topics for the roadmap update. Staff published a draft <u>Matrix of Goals and</u> <u>Issues/Barriers</u> to frame the roadmap update. Public comments were received during and following the webinar, and staff will update the matrix to reflect those comments.

Staff is also developing a VGI Workshop *Discussion Document* that describes the current state agency interactions of VGI related policies and programs and a series of discussion questions to explore during the workshops.

Overview

During the morning of October 29, 2018, this workshop will include a vehicle and charging technology showcase for the public and stakeholders to learn about vehicle grid integration efforts. Following the showcase, staff will present an overview of the VGI Roadmap process and present updates to the draft *Matrix of Goals and Issues/Barriers*. On both days, the workshop will feature panel discussions with state agency representatives, electric vehicle industry experts, utility representatives, and environmental-based organizations on actions and priorities to include in the VGI Roadmap.

Public Comment

Oral comments. Staff will accept oral comments during the workshop. Comments may be limited to three minutes per speaker. Any comments may become part of the public record in this proceeding.

Written comments. Written comments should be submitted to the Dockets Unit by 5:00 p.m. on November 21, 2018. Written comments will be also accepted at the workshop, however, the Commission may not have time to review them before the conclusion of the meeting.
