## **Background**

Assembly Bill 109 (Ting, Budget Act of 2017, Chapter 249, Statutes of 2017) provided \$6 million in Greenhouse Gas Reduction Fund monies to the Energy Commission to support renewable energy projects in the agriculture sector to reduce greenhouse gas emissions. Senate Bill 856 (Committee on Budget and Fiscal Review, Chapter 30, Statutes of 2018) provided an additional \$4 million in funding for these purposes. To implement these efforts, the Energy Commission developed the Renewable Energy for Agriculture Program (REAP) as a competitive grant program to support the installation of onsite renewable energy projects serving agricultural operations located in California.

As a program funded through California Climate Investments, REAP is designed with the primary goal of reducing greenhouse gas emissions, emphasizing projects in disadvantaged and low-income communities and is envisioned to foster projects with co-benefits serving the local community, benefitting public health, and reducing air pollution.

The proposed *Renewable Energy for Agriculture Program Draft Guidelines* describe the proposed REAP program structure, eligibility criteria for selecting projects for funding, solicitation procedures, project implementation requirements, project reporting, and statutory requirements. Information gathered from past workshops and public comment periods informed the content of the proposed *Draft Guidelines* now considered for adoption by the Energy Commission.

On October 8, 2018, the *Renewable Energy for Agriculture Program Draft Guidelines, Version 2,* was posted for public comment. Several comments were received, and some minor clarification changes were made to the current *Renewable Energy for Agriculture Program Draft Guidelines* under consideration for adoption.

The Renewable Energy for Agriculture Program Draft Guidelines Publication # CEC-300-2018-006-SD3 was released to the public on October 29, 2018, and is available at https://www.energy.ca.gov/renewables/18-MISC-03/documents/.

## **Public Comment**
