**RESOLUTION ADOPTING FORMS
AND INSTRUCTIONS FOR
ELECTRICITY RESOURCE PLANS**

WHEREAS, the California Energy Commission (Energy Commission) is directed to "conduct assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices" and to "use these assessments and forecasts to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety" (Pub. Resources Code § 25301(a)); and

WHEREAS, the Integrated Energy Policy Report (IEPR) contains these assessments and associated policy recommendations and is adopted every two years; and

WHEREAS, the Energy Commission may require the submission of electricity resource plans and other information from utilities and other market participants to perform these assessments (Pub. Resources Code § 25301, subd. (a)); and

WHEREAS, Cal. Code Regs., tit. 20 § 1347 identifies the contents of topics to be addressed in each load-serving entity's (LSE's) electricity resource plan and specifies that such plans must be submitted according to forms and instructions adopted by the Energy Commission; and

WHEREAS, Energy Commission staff has prepared and posted draft Forms and Instructions for Electricity Resource Plans Prepared in Support of the 2019 Integrated Policy Report (*2019 IEPR*); and

WHEREAS, several LSEs that are exempt from filing pursuant to Cal. Code Regs., tit. 20 § 1350 voluntarily agreed to file electricity resource plans in past IEPR cycles and are being requested to file in this cycle;

THEREFORE, BE IT RESOLVED, the California Energy Commission hereby adopts the Forms and Instructions for Electricity Resource Plans Prepared in Support of the 2019 Integrated Energy Policy Report for the *2019 IEPR*, along with any changes identified at its November 7, 2018 Business Meeting.
